Triomphe hereby takes the responsibility to Design, Develop and Host a Website and Software for the Mar Ivanios College of Arts And Science, Mavelikkara (MICAS), on following terms and conditions.

General

- 1. The Domain for the website will be www.marivanioscollege.in
- 2. The Annual Update of Website including Website testing from the side of both parties and user trainings shall be completed on or before 1st February 2018.
- 3. The MICAS holds the ownership of the domain name and product that is customized for them by the Triomphe.
- 4. The Triomphe has no right to claim ownership on the data i.e. the data, images and videos in the website.
- 5. The Triomphe has no right to sell or share the website i.e. the data, images and videos in the website to any third party.
- 6. Triomphe shall collect all the needed data from the PRO of MICAS and process it to the website and Software.
- 7. The Login Credentials shall be given to the Director on completion of Website and thereafter the MICAS can Add, Update and Delete data and images from the website.
- 8. The AMC shall be Rs. 50,000.00 (Fifty Thousand Rupees Only. It includes the charges for design, develop and hosting the website and Software.
- 9. The agreed amount shall be paid to the Triomphe on the completion of the website and Software.

- 4. The First party shall pay to the Second Party Rs.50,000/-(Fifty Thousand Rupees Only). towards the hosting charges, server charges including maintenance of the website and Software for an year.
- 5. Timely changes in the website shall be done by the Second party whenever it is needed and requested by First Party.

Content and Language

- 1. Language used in the Website is English and Malayalam.
- 2. The content in the website shall be the data collected from the PRO of MICAS and the data those shall be updated by MICAS' Web Administrator from time to time.

Security
